6 Be It Enacted by the Legislature of the State of Florida:

8 Section 1. Section 281.01, Florida Statutes, is amended to
9 read:

10 281.01 - Definitions

11 For the purposes of ss. 281.01-281.08, the term "Capitol
12 Complex" includes that portion of Tallahassee, Leon County,
13 Florida, commonly referred to as the Capitol, the Historic
14 Capitol, the Senate Office Building, the House Office Building,
15 the Knott Building, the Pepper Building, the Holland Building,
16 the Memorial Park, the R.A. Gray Building and associated parking
17 garages and the curtilage of each, including the state-owned
18 lands and public streets adjacent thereto within an area bounded
19 by and including Calhoun Street, Pensacola Street, Monroe
20 Street, Jefferson Street, Duval Street, Martin Luther King Jr.
21 Boulevard, Madison Street, and Gaines Street. The term shall
22 also include the State Capital Circle Office Complex located in
23 Leon County, Florida.

24 Section 2. Subsection (1) of Section 272.09, Florida
25 Statutes, is amended to read:

26 272.09 - Management, maintenance, and upkeep of Capitol

28 (1) For purposes of this section, the term "Capitol
29 Complex" means the portion of the Capitol Center commonly
30 referred to as the Capitol, the Historic Capitol, the Senate

46 the Knott Building, the Pepper Building, , the Holland Building,
47 the Memorial Park, the R.A. Gray Building and associated parking
48 garages and the curtilage of each, including the state-owned
49 lands and public streets adjacent thereto within an area bounded
50 by and including Calhoun Street, Pensacola Street, ~~Monroe~~
51 Street, Jefferson Street, Duval Street, Martin Luther King Jr.
52 Boulevard, Madison Street, and Gaines Street. The term shall
53 also include the State Capital Circle Office Complex located in
54 Leon County, Florida.
